EXHIBITOR APPLICATION/CONTRACT: TERMS AND CONDITIONS FOR EXHIBITING

1. Vendors will be considered to be “registered” ONLY when the vendor contract and payment have been received AND you have been notified of your booth space by the Event Director or Event Chair. Invoice will be sent from Paypal within 48 hours for you to make your payment within 24 hours.
2. All payments and contracts must be received in email no later than February 24th, 2023. **NO EXCEPTIONS!**
3. **Cancellations:** Notice must be sent in writing to the Event Director prior to February 24th, 2023. Any cancellations after this date will not be eligible for a partial or full refund.
4. Each booth includes space rental, two chairs. Tables not included. Any additional furnishings, including tables needed for booths, must be provided by the exhibitor.
5. Electricity is available for an additional \$10.00. Please mark yes/no on the contract form below.
6. Vendors will be greeted in the front of the school driveway and will receive help unloading from 8:00am-9:45am. Vendors should stay at their booth area all day. Displays should remain intact until the show closes. Early tear down creates a sense of closure for the day.
7. Vendors may not assign/sublet/re-sell any part of their space without written consent of the Event Director.
8. Any person or firm not exhibiting is prohibited from soliciting business in any part of the exhibit area/site. The Colony Band Booster Club reserves the right to refuse service and/or entry to any person or firm.

9. Vendors will have the option of purchasing lunch that will be delivered to your booth by a Marching Band Student. You will receive an email once the menu has been finalized or you may obtain a copy of the order form online when available.

10. Any vendor who displays a company brand item which is not listed on the registration contract will be asked to leave the show with no refund and no inappropriate items should be sold.

The Colony High School and The Colony Band Booster Club will not be responsible for any loss, damage, or injury that may occur to any exhibitor, their representatives or property, before, during or after show hours. Exhibitors should insure themselves against such claims, and by signature on application, release The Colony High School and The Colony Band Booster Club from any and all liability. All merchandise and exhibits must conform to Denton County fire codes and ordinances and any regulations of the school. Exhibitors agree to abide by official show rules and regulations as set forth by the Show Director. Exhibitors are each responsible for the collection and payment of any sales tax, and obtaining of licenses or permits, which may be required by Denton County, Texas. Realize there is NO GUARANTEE of booth assignments at the time of application unless you reserve the same space from the previous year. All other booth assignments will be first come, first serve.
